Here is some of what we will do in 2015. We want to ensure that the State of Florida takes the \$55 billion in federal funds to finally help close the healthcare gap. We want to ensure that the Water and Land Legacy Amendment funding is spent wisely and distributed to help all parts of the state. We will push to reduce the expansion of a parallel system of private schools that divert funds from our public schools with no accountability. We will stop proposed legislation to allow guns in our public schools and universities.

### VISITS TO DAY CARE CENTERS

Jean Schiffbauer and Janet Allen visited four VP-K (voluntary prekindergarten) centers with the goal of testing an evaluation form Jean developed. They were pilot testing the questions to



determine the needs of center staff. The first visit was to the Baby Gator center on UF campus. Later, accompanied by Andi Lybrand, the Training and Curriculum Coordinator of the Early Learning Coalition, they visited 3 very different centers in Gainesville.
